Item 7.01 Regulation FD Disclosure.

On September 24, 2014, Acorda Therapeutics, Inc. ("Acorda") announced that it entered into a definitive agreement with Civitas Therapeutics, Inc. ("Civitas") under which Acorda will acquire Civitas for approximately \$525 million. In connection with the closing of this transaction, Alkermes, Inc., a wholly owned subsidiary of Alkermes plc, expects to receive (i) \$30 million for the sale of certain commercial-scale pulmonary manufacturing equipment used by Civitas and (ii) approximately \$29 million, subject to release of all amounts held in escrow, for its approximate six percent (6%) equity interest in Civitas. These payments will both be recorded within other income, and Alkermes, Inc. expects a related cash tax charge of up to \$12 million. None of these payments will impact non-GAAP net income. Subject to customary closing conditions, the transaction is expected to close in the fourth quarter of 2014.
