Item 5.07 Submission of Matters to a Vote of Security Holders.

On May 13, 2022, Alkermes plc (the "Company") held an extraordinary general meeting of shareholders (the "EGM"). At the EGM, shareholders approved certain amendments to the Company's Articles of Association to provide for plurality voting for contested elections, with the votes cast as follows: 143,396,054 votes for; 2,059,122 votes against; and 89,793 votes abstaining.
