KNOW ALL MEN BY THESE PRESENTS, that the undersigned hereby revokes all powers of attorney relating to the following matters and constitutes and appoints each of James M. Frates, Iain M. Brown, Jennifer Baptiste, Samuel Parisi, Shantale Harb, Christopher Ciulla, Stephanie Roche, Cole Ruwet, Mitchell S. Bloom and Rob Puopolo, and any one of them acting singly, as true and lawful attorneys-in-fact and agents, with the full power of substitution and resubstitution, for the undersigned and in the undersigned's name, place and stead, in any and all capacities (until revoked in writing) to:
